Context Statement



St Agnes School P-6 is classified as Category 6 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 8% Aboriginal students, 3% students with disabilities, 8% students with English as an additional language or dialect (EALD) funded background. Performance Summary NAPLAN Proficiency



Attendance Comment


In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.


Proportion of agree/strongly agree responses (%)


Proportion of agree/strongly agree responses (%)

Leadership and Decision Making


Proportion of agree/strongly agree responses (%)

As Chair for the first time this year I was on a bit of a learning curve, so first I would like to thank everyone who helped me to get my head around policy, procedure and process and were supportive and patient. We were delighted welcome back existing members this year (Ryan, Linda, Kristel) and to see some bright new faces on council, including Caroline and Kiri.

Governing Council meets eight times a year (twice per term) and primarily our role is to oversee finance, policy review and approval, fundraising and the OSHC service. Please find below some of the highlights from 2023.

- **Finance:** I am really pleased to report that our financial position is stable, which has not always been the case. This is a result of a lot of hard work by Sandee and Vicky and so I want to thank them for their efforts in this respect.
- Policy: We continued to evolve our policies and processes in 2023. This included a review of our policies in relation to the following:
